## **Old Business**

- 2. **The 2019 Annual Financial Statements**: The Treasurer mentioned that the annual financial statements of the club for 2019 were sent out to all members for review. Motion by Dennis Gubert to accept these statements as submitted and seconded by Showhib Jooya. Motion carried.
- 3. **Financial Report**: Our checking account stands at \$19,716 and the GIC account at \$36,821.
- 4. **Truck Report**: Brian Nicholson reported that the club truck has been winterized and that the truck is still in very good working order.
- 5. *Trophy Report*: None
- 6. Constitution and Rules Committee Report: None. David Walker submitted his written resignation as Chair of this committee due to personal circumstances. Thank you kindly David for your long and dedicated service to our club in this capacity ... MUCH appreciated!

- 7. **Property Report**: David Walker reported that the rent is being paid on time, and that he conducted a thorough inspection of the rental property in December 2019 to find the property in good shape for its age (David submitted a written report in this regard). Mr. Lau, our renter, has agreed to complete some work around one of the doors where the plaster and paint have deteriorated. Mr. Lau reported that the furnace does not work properly all the time, and David Walker was asked if he will please arrange with Mr. Lau to have the furnace serviced as soon as possible, and that the club will reimburse Mr. Lau for the expense.
- 8. **Show Report**: Dennis Gubert thanked everybody who helped with putting on a fine pigeon show on January 11<sup>th</sup>, 2020 and cleaning up the clubhouse on January 25<sup>th</sup>. 101 Birds were entered, and 6 birds were auctioned off for a profit of \$359. **Thanks again guys ... well done!**
- 9. **Proposals for buying a new club truck**: After further discussions between members of the Truck Committee and our driver Alex Mota, it was recommended that the club hold off on buying a new club truck for now, and see if our old truck will serve us for another year.
- 10. **Voting on the 2020 Race Schedules**: The 2020 Old Bird and Young Bird race schedules as submitted by the Race Schedule Committee were voted in.
- 11. A special Young Bird race during 2020: Dennis Gubert put forward a motion, seconded by Wayne Lochbaum, that members who want to participate in the 2020 special young bird race, could nominate up to 10 young birds at \$10 per bird to compete in this race. The money collected for the nominations will be distributed according to a formula to be decided on, eg. 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> place.
